The 17 year old could end up in juvenile detention

If the friend is over 18 they could be charged with a serious charge of Contributing to the Delinquency of a Minor which is not expungeable Dec 6 2021 Is it illegal for 16 year old to date 14 year old what happens when they turn 17 can they not date anymore kiss dates ect? I got approval from her parent mom to date her im currently 16 years old 17 in may she just turned 14 October 20

I was wondering if we are legally aloud to date and what happens when I turn 17? Oct 19 2017 Im a 17 year old and want to know if it is against the law to date a fourteen year old girl

I will be turning 18 semi soon and want to know any law however obscure that may prevent me from dating her Sep 25 2014 Can i date a 17 year old being 19 years old? We have been dating a couple weeks her parents love me to death and they're okay with it

Aug 4 2020 No. The situation creates a very real risk to the 19 year old of possession phonographic images of a minor under the age of 18

Although the age of consent in Illinois is 17 and both 17 and 19 year old may engage in any mutually consensual sexual activities unless one has a position of authority guardianship or mentorship over another Mar 24 2013 It is illegal to have sexual contact which can include touching or caressing with a minor

There is an exception which generally allows parties who are both still in high school AND the age difference between them is less than 1 year 365 days

Thus a 18 year old senior male in high school with a Birthday of say April 1st could date a 17 year old Junior female also in high school with a Jan 3 2020 I 17 sent nudes to a minor 14 and the nudes were shared and leaked all over my school

They were sent to a snapchat account ran by a legal adult which is an account that publicly shames and posts nude photos of minors. Will I get in trouble for sending the photos of myself? Jan 3 2019 Since IL sets the age at 17 you would
