My question is should I file a report on this place? Could I be in trouble for simply getting a non sexualmassage? Dec 7 2012 Pulled over after visiting a massageparlor I live in Florida. I made a bad choice and visited a massageparlor about an hour from where I live

After pulling out an unmarked car flashed police lights and pulled me over Nov 19 2020 A friends went to amassageparlor and paid using credit card he wants to know the likelihood of him getting in trouble? My friend recently went to one of those shadyAsian massageestablishments

Long story short he charged both the initial payment and tip to his credit card in exchange for some extra favors. He ended up paying around Aug 20 2021 1 Going to amassageparlor is not a crime. Getting amassageis not a crime. Sexual contact in exchange for money IS a crime

You have not admitted to that activity so DO NOT post anything to suggest that you did. Anything you say can and will be used against you

2 Police stings of suspected illegalmassageactivities usually involve active surveillance of johns coming out of the Mar 1 2015 Amassageparlor was busted in my area and a detective sent me a letter saying they wanted me to come into the station and discuss why I was in the message parlor Feb 21 2022 I got a happy endingmassageat a parlor in Texas 6 days ago

After doing some googling I found out this is now a felony in Texas. Themassageis still open and hasnt been raided

What are my chances of being arrested after the fact for this? Is there a strong likelihood that police will ever reach out to me? There are multiple cameras attached to the building and I would presume law Nov 19 2020 My friend recently visited anAsian massageparlor
