Simple assault involves an intentional act that causes another person to be in reasonable fear of an imminent battery. May 29 2025 The crimes of assault, assault and battery, and aggravated assault all involve intentional harm inflicted on one person by another.

Any crime involving a physical attack or even the threat of an imminent attack is usually classified as assault, a battery, or both. Assault suggests a direct attempt to overpower by suddenness and violence of onslaught. In assault and battery, assault refers to the act that causes the victim to immediately apprehend a harmful or offensive contact, whereas battery refers to the act that causes the actual contact.
