Explore who can request one and find out what information is required during the screening process When submitting a complaint relating to the denial or revocation of asecurityclearance you must submit your complaint within 30 days after receipt of the notice issued by the department responsible for the denial or revocation of yoursecurityclearance Secretclearanceis only granted after a reliability status is cleared with a positiveCSISsecurityassessment

This level of clearance will grant the right to access designated and classifiedinformationup to Secret level on a need to know basis Dec 27 2024 CSISdetermines whether the file can be cleared i.e

If you are approached byCSIS you can Politely decline to talk to them. Get legal advice immediately For an online application to be successfully submitted to the PersonnelSecurityScreening Unit it must first be approved by the hiring official identified by the individual.
