Enter the amount charged for a purchase before all applicable sales taxes including the Goods and Services Tax Harmonized Sales Tax GST HST and any Provincial Sales Tax PST are applied If you own or operate a business in Canada you need to know about the goods and services tax GST and the harmonized sales tax HST

This guide provides general information such as how to collect record calculate and remit the GST HST

It also includes line by line instructions to help you fill out your GST HST return The HST includes the provincial portion of the sales tax but is administered by the Canada Revenue Agency CRA and is applied under the same legislation as the GST

The HST is in effect in Ontario New Brunswick Newfoundland and Labrador Nova Scotia and Prince Edward Island Apr 29 2025 Under the Excise Tax Act Canada ETA GST is payable by the recipient of a taxable supply of goods or services made in Canada

Generally a supplier of such goods or services is required to register for collect and remit the applicable GST to the CRA Oct 2 2025 In Canada businesses collect sales tax on behalf of the government and remit it to the Canada Revenue Agency

Also known as a Value Added Tax VAT in some countries sales taxes in Canada come in various formats. There is the federal sales tax referred to as the Goods and Services Tax GST Most goods and services purchased in Canada or brought into Canada are taxable

Examples of taxable goods and services can be found in the CRA Guide RC4022 under the heading Taxable Supplies Jun 26 2025 From the latest 2025 rates to intricate rules for businesses this resource is your definitive guide to sales tax in Canada.
