Specifically this is the cost of transporting the decedent from the place of death to our facility Yes if the Medical Examiner believes it will assist the inquiry into cause and manner of death the decedents tissue s organ s body fluid s may be retained for analysis and or evidentiary purposes pursuant to California Government Code Section 27491.4 This is not a search of all deaths that occur in Los Angeles County
