Incorporated as a not for profit foundation in 1971 and headquartered in Geneva, Switzerland, the Forum is tied to no political, partisan, or national interests May 6 2015 Corruption is considered a strong constraint on growth and development

The academic literature, however, finds different effects of corruption on economic performance. Some research considers corruption a 'grease the wheels' instrument

In this view, corruption helps to overcome cumbersome bureaucratic constraints, inefficient provision of public services, and rigid laws Huntington 1968 Jun 9 2015 The Forum's Partnering Against Corruption Initiative, a partnership of more than 100 companies, is a strong example of private sector involvement and is currently one of the leading global business voices on anti corruption and transparency Dec 4 2023 International Anti Corruption Day is recognized on 9 December each year and highlights the actions people can take to tackle this global crime Mar 9 2017

Traditional approaches to fighting corruption tend to focus on rules, compliance, and enforcement

We need to rethink this to build societies with integrity.
