It does not dissolve when its owners or shareholders die because it is considered a separate person. A corporation can Combined Reporting. Any corporation currently filing in Virginia would generally be considered part of a unitary business which may consist of a single corporate entity or multiple corporate entities. These transactions typically result in a separate accounting for a separate entity gain or loss to the intercompany seller. A business conducted directly or indirectly by one corporation is unitary with that portion of a business conducted by another corporation through its direct or indirect interest in a partnership.
