The Office collaborates with the Working Group to bring attention to the issue of arbitrary detention with the goal of ending the practice. Arbitrary detention exposes the victim to the possibility of further violations including torture or other cruel, inhuman and degrading treatment or punishment enforced and involuntary disappearances and extrajudicial execution. Jan 9 2025 GENEVA In two landmark decisions the UN Human Rights Committee has ruled that Australia remained responsible for the arbitrary detention of asylum seekers redirected or transferred to offshore detention facilities in the Republic of Nauru. International human rights law provides a clear and universal framework relating to detention enshrined by the following standards. Jan 8 2025 GENEVA UN experts* today called on the United States to immediately release Zayn al Abidin Muhammad Husayn, known as Abu Zubaydah, who remains detained for almost 20 years without charge at the Guantnamo Bay detention facility and naval station. Dec 12 2025 Introduction At the invitation of the Government of Australia the United Nations Working Group on Arbitrary Detention conducted an official visit to Australia from 1 to 12 December 2025.

The Working Group was represented by Ganna Yudkivska (Ukraine) and Matthew Gillett (New Zealand) supported by secretariat staff of the Office of the UN High Commissioner for Human Rights.
