Nov 13 2025 WASHINGTON The Internal Revenue Service announced today that the amount individuals can contribute to their 401 k plans in 2026 has increased to \$24 500 up from \$23 500 for 2025 Dec 19 2025 The 401 k contribution limit for 2026 is \$24 500 for employee salary deferrals and \$72 000 for the combined employee and employer contributions

If you're age 50 or older you're eligible for a catch up contribution and can contribute up to an additional \$8 000 in 2026 Dec 20 2025 One nice feature of 401 k's is that they have generous contribution limits including catch up limits

In 2026 you'll be forced to make your catch up Roth style if your 2025 income is over \$145 000 Dec 7 2025 Starting in 2026 the 401 k contribution limit increases to \$24 500 for 2026 up from \$23 500 in 2025
