STEP 2 After you have determined when your case is being heard go to Telephonic Hearings and Conference Lines for information on how to call into hearings Use the link below to search for an appellate case. You may search by the case number a party to a case or an attorney participating in a case

You can also enter a case number or trial court case number in the Look Up Case box in the upper right corner of this screen. by Case Number The court maintains attorney addresses in CourtView using the business address on file with the Alaska Bar Association
