It was long hoped that what works against gangs could also help build community resilience to the emergence of homegrown violent extremists but recent research suggests thatgangmembers and domestic extremists have too few traits in Oct 27 2011 Gangmembers engage in a higher level of serious and violent crime than their non gang involved peers

Research about gangs is often intertwined with research about gun violence and drug crime
