It is most often defined as a pattern of continuing unwelcome behavior that unreasonably interferes with an employees work performance or that creates an intimidating hostile or offensive work environment Harassment is illegal when it is so frequent or severe that it creates a hostile or offensive work environment

It is also illegal when it results in an adverse employment decision such as the victim being fired or demoted. The victim and the harasser can be any gender or the same gender Any person who feels they have been subject to workplace harassment may file a complaint with the ICRC

Complaints can be filed in person by mail fax or on our website. Employment complaints must be filed within 180 days from the date of the alleged discriminatory act.
