Before the clothing may be brought into the jail the adult in custody must complete a clothing exchange form. Jail staff will not accept clothing for an adult in custody unless the form has already been completed. Aside from visiting an adult in custody at their facility there are three main ways to contact an AIC: phone calls, letters, and electronic communications.
