It is designed to prevent or reduce any adverse effects on the environment and human health through the proper management of mining waste

It also aims to Ensure the long term stability of disposal facilities Prevent or minimise water and soil pollution arising from acid or alkaline drainage and the leaching of heavy metals Find out about EU law policy and targets to reduce the amount of waste sent to landfill to protect the environment and human health Hazardous waste Hazardous materials are any materials that have the potential to harm human health damage property cause harm to the environment

Hazardous materials can be solid liquid or gas. Many industrial commercial pharmaceutical agricultural and domestic chemicals contain hazardous materials

Some common examples include paint cleaning chemicals degreaser detergent pesticides Apr 30 2025 Solid waste refers to any unwanted or discarded material that is not in a liquid or gaseous state

The solid waste includes a wide range of materials generated from various sources such as households industries commercial establishments construction
