Oct 20 2025 The use of the death penalty is not consistent with the right to life and the right to live free from torture or cruel inhuman or degrading treatment or punishment. There is growing consensus for universal abolition of the death penalty

Some 170 States have abolished or introduced a moratorium on the death penalty either in law or in practice

Despite this abolitionist trend the death Although Article 6 of the ICCPR permits the use of the death penalty in limited circumstances it also provides that nothing in this article shall be invoked to delay or to prevent the abolition of capital punishment by any State Party to the present Covenant

Safeguards guaranteeing protection of the rights of those facing the death penalty Capital punishment may only be carried out pursuant to a final judgement rendered by a competent court after legal process which gives all possible safeguards to ensure a fair trial at least equal to those contained in article 14 of the International Covenant on Civil and Political Rights including the right of anyone suspected of or charged Jan 31 2024 The infliction of the death penalty is profoundly difficult to reconcile with human dignity the fundamental right to life and the right to live free from torture or cruel inhuman or degrading treatment or punishment said UN Human Rights Chief Volker Trk The use of the death penalty is egregious against any human being Trk said while addressing the Human Rights Council

When Mar 10 2025 The country formally outlawed capital punishment in 2024 with the enactment of the Death Penalty Abolition Act

This landmark legislation follows years of judicial decisions that gradually reduced the number of crimes punishable by death Oct 10 2024 The death penalty is contrary to human dignity is incompatible with the right to life and does not lead to justice

Thus is the sentiment of UN Human Rights and human rights defenders across the globe who further state there is little to no evidence that it deters crime and advocate for its universal abolition Introduction The provision of the death penalty remains in force in various criminal laws of Bangladesh

The penal laws of Bangladesh provide capital punishment for 33 offences.¹ Once an accused is found guilty of those offences by a competent court it can sentence him/her with a death penalty as the maximum punishment

Every year a large number of accused persons are being sentenced to death Oct 9 2023 In effect a number of States continue to impose the death penalty in violation of their human rights obligations including for crimes that do not
