After pulling out an unmarked car flashed police lights and pulled me over Apr 25 2011 A legitimatemassageis not sexual activity but you will have a problem defending that case. There is a maximum \$1000 fine 180 days in county jail and one year probation

Realistically you are looking at a \$500 fine but the arrest and conviction will be on your record. The Sayreville Court is very reasonable and the prosecutor is terse but fair Mar 27 2024 I visited amassage parlorin Orlando Florida that offered extra services

The masseuse wore little clothing barely spoke English and repeatedly asked me if I wanted extra services Mar 1 2015 Amassage parlorwas busted in my area and a detective sent me a letter saying they wanted me to come into the station and discuss why I was in the messageparlor Nov 19 2020 A friends went to amassage parlorand paid using credit card he wants to know the likelihood of him getting in trouble?
