However the analysis shows that in addition to age a physician's medical specialty and gender are prominent factors in the likelihood of being sued during a career in medicine

Age Physicians with more years in practice have had more exposure to risk Medical liability claims impose costs on society monetary and non monetary so examining their prevalence is important
