my kids play out on the deck and I just want to know if thats legal? this is almost everyday May 13 2018 If you do not want a person to come onto your property and the person has no legal right to be on your property you can tell the person to stop coming onto your property

If the person continues to come onto your property after being told not to be there you call 911 to report a trespasser. The police will come to investigate
