Learn more A trial is a formal legal proceeding where legal claims are presented evidence is examined and witnesses are heard

It is overseen by a judge jury or other adjudicator who determines the guilt or innocence of a party in a criminal case or the outcome of a dispute in a civil case A proceeding in which opposing parties in a dispute present evidence and make arguments on the application of the law before a judge or jury The case is expected to go to trial TRIAL meaning 1 a formal meeting in a court in which evidence about crimes disagreements etc

is presented to a judge and often a jury so that decisions can be made according to the law 2 a test of the quality value or usefulness of something A trial is an experiment in which you test something by using it or doing it for a period of time to see how well it works
