Minutes also known as protocols or informally notes are the instant written record of a meeting or hearing

They typically describe the events of the meeting and may include a list of attendees a statement of the issues We was is not standard English it is used in some regional dialects The verb to be has two simple past forms in Standard English I he she it was and you we they were
