Unitarybusiness meansa singleeconomic enterprise that is made up either of separate parts ofa singlebusinessentity or of a commonly controlled group ofbusinessentities that are sufficiently interdependent integrated and interrelated through their activities so as to provide a synergy and mutual benefit that produces sharing or exchange of value among them and a significant flow Nov 22 2025 Once the ownership link is established the taxpayer must confirm that theaffiliatedcorporationsare engaged in a single unitarybusiness
