Understanding REACH REACH is a regulation of the European Union adopted to improve the protection of human health and the environment from the risks that can be posed by chemicals while enhancing the competitiveness of the EU chemicals industry The REACH Regulation initially made no specific provision for nanomaterials

In 2018 the Commission adopted Commission Regulation (EU) 2018/1881 to modify REACH technical Annexes I, III and VI, XII introducing nano specific clarifications and provisions This is unique source of information on the chemicals manufactured and imported in Europe

Registration is based on the one substance one registration principle REACH IT is now issuing list numbers in the new format

Example of the new format A00 000 0 Note that the change may affect your companys recording systems outside REACH IT Substance identification is a process by which the identity of the substance is established

Accurate identification of a substance is a pre requisite to most REACH CLP and biocides processes. In particular it enables joint REACH registrations to be prepared efficiently and correctly and ensures that test data is appropriate for the substance registered under REACH

This leads to a robust REACH IT is the central IT system that supports Industry Member State competent authorities and the European Chemicals Agency to securely submit process and manage data and dossiers

These three parties each have access to specific functions of REACH IT which they can use to fulfil their requirements under the REACH and CLP regulations.
