The cases against former NOCOMO leaders Nicki Samson and Margaret Helzer have been continued. The two were charged earlier this year with stealing \$25 000 or more from the nonprofit organization. On Monday morning Samsons case was continued to 9 30 a.m. on Jan

22 2024 at Jun 15 2023 Samson and Helzer were each charged in February with two felony counts of stealing for allegedly carrying out a scheme that moved \$483 000 from NOCOMO a nonprofit sheltered workshop into accounts accessible by Samson and Helzer without the boards authorization
