A unitary business is a group of two or more corporations related by common ownership and sufficiently interdependent integrated or interrelated through their activities to file as one group

Each separate group requires its own top consolidation and elimination Apr 8 2024 When a business acquires another entity or acquires the assets of another entity questions arise as to whether the combined entities are unitary and when the unitary relationship begins

Unitary business means business activities or operations which result in a flow of value between them What is a unitary business group? The term unitary business group means a group of persons related through common ownership whose business activities are integrated with dependent upon and contribute to each other If a business is considered unitary it must file a combined report for California state income tax purposes

This means that the income and apportionment factors of all the members of the unitary business are combined to determine the amount of income attributable to California To register as the managerial member of a combined group for Corporation Business Tax purposes login to Online Registration Change Service using the taxpayer's current New Jersey identification number and corporation business tax PIN

Check the box Register as the Managerial Member of a Unitary Combined Group and follow the onscreen prompts.
