Serial is a podcast from the creators of This American Life hosted by Sarah Koenig. Serial tells one story a true story over the course of a season. A potential alibi surfaces and then disappears again at the worst possible time for Adnan's case. The high school scene, the shifting statements to police, the prejudices, the sketchy alibis, the scant forensic evidence, all of it leads back to the most basic questions: How can you know a person's character? Asia's Affidavit January 13, 2015 Asia wrote this affidavit after hearing prosecutor Kevin Urick on Serial. She reaffirms that she saw Adnan in the library on the day Hae disappeared.

Asia says she decided not to testify at Adnan's original post-conviction hearing in 2012 after a phone conversation she had with Urick. In 2016, Adnan's attorney introduced new evidence and presented a case for why his conviction should be overturned. Serial covered what happened day by day in the three audio updates below.
