A potential alibi surfaces and then disappears again at the worst possible time for Adnan's case. Serial is a podcast from the creators of This American Life hosted by Sarah Koenig. Serial tells one story, a true story over the course of a season. Not for one extraordinary case, instead Serial wanted to tackle the whole criminal justice system.

To do that, we figured we'd need to look at something different: ordinary cases. The high school scene, the shifting statements to police, the prejudices, the sketchy alibis, the scant forensic evidence—all of it leads back to the most basic questions: How can you know a person's character? How can you tell what they're capable of? In Season One of Serial, she looks for answers. But then a prosecutor in the Baltimore State's Attorney's office stumbled upon two handwritten notes in Adnan's case file and they changed everything. Serial is a podcast designed to be listened to in order.

If you're just landing here, please go back and start with Episode 1. In 2016, Adnan's attorney introduced new evidence and presented a case for why his conviction should be overturned. Serial covered what happened day by day in the three audio updates below.

In 2019, Maryland's highest court reversed a decision to give Adnan a new trial.

After 15 months of reporting, we take out everything we've got: interviews and documents and police reports. We shake it all out and we see what sticks. Serial is a podcast designed to be listened to in order.

If you're just landing here, please go back and start with Episode 1. Asia's Affidavit, January 13, 2015: Asia wrote this affidavit after hearing prosecutor Kevin Urick on Serial. She reaffirms that she saw Adnan in the library on the day Hae disappeared.

Asia says she decided not to testify at Adnan's original post-conviction hearing in 2012 after a phone conversation she had with Urick.
