So I called up and they said they offered Japanese Thai deep tissue and erotic
Aug 20 2021 1 Going to a massage parlor is not a crime. Getting a massage is not a crime. Sexual contact in exchange for money IS a crime

You have not admitted to that activity so DO NOT post anything to suggest that you did. Anything you say can and will be used against you

2 Police stings of suspected illegal massage activities usually involve active surveillance of johns coming out of the Oct 1 2016 The Supreme Court of The United States has ruled that happy endings can be considered a legitimate massage procedure and in no way should be considered prostitution

Is this correct? Is happy ending is still a prostitution or it is not any more?
I am a licensed massage therapist and it is always a struggle for me to deny it Mar 20 2017 if the massage is intended for sexual satisfaction and involves the genitals then the answer would be yes

It is unlikely you would be arrested for making an appointment since you are not soliciting Mar 1 2014 I am a professional massage therapist in Clinton Twp. MI. I am in private practice. I give a great massage which does not include massaging the genitals

All of my clients are male. I have been losing a lot of business because I do not do a hand release as most of the other therapists do. Would it be illegal in Michigan in the Clinton Twp

area to do a hand release? Apr 25 2011 A legitimate massage is not sexual activity but you will have a problem defending that case. There is a maximum \$1000 fine 180 days in county jail and one year probation

Realistically you are looking at a \$500 fine but the arrest and conviction will be on your record. The Sayreville Court is very reasonable and the prosecutor is terse but fair Jul 16 2014 Thank you

Is a nude massage considered sexual contact or does it have to involve touching the genitalia? Assuming you're speaking of the masseuse being nude and not the client I think that a nude massage for a fee would be hard to defend as not being sexual

Involving the genitalia would make it impossible to defend as being sexual Sep 24 2019 I was told by a friend about nuru massages and wanted to know if it is illegal
