The Utah Department of Public Safety has become aware of scammers calling from what appears to be a State government number and identifying themselves as BCI Officers. If you reside in a state other than Utah that honors the Utah permit you will be asked to upload a copy of your valid resident state permit.

Share sensitive information only on secure official Utah.gov websites. Provisional Concealed Firearm Holders. If you have a Provisional concealed firearm permit you cannot renew it. You must apply for the standard concealed firearm permit.

Instructions can be found on the BCI website. If you choose not to get a permit in Utah and you travel to a state that requires a permit to carry open or concealed then you are subject to the laws of that state. Due to legislation passed in the 2025 session the following BCI fees will be increasing effective July 1 2025. Right of Access, Utah Criminal Record New Fee \$20. BCI is a member of the Western Identification Network WIN which allows Utah agencies to access data from the Automated Fingerprint Identification System AFIS consisting of seven western states: the California Department of Justice, CAL DOJ and the Washington State Police. The Utah concealed firearm permit is valid for a period of five years.

The Bureau of Criminal Identification will send a renewal reminder letter to you approximately three months prior to your expiration. Criminal Identification BCI Menu.
