These annual updates account for the Jun 6 2017 Fact Sheet This is the 31st tobacco related Surgeon Generals report issued since 1964

It describes the epidemic of tobacco use among youth ages 12 through 17 and young adults ages 18 through 25 including the epidemiology causes and health effects of this tobacco use and interventions proven to prevent it
