The incident happened around 10 pm on April 27 2024 when a car carrying the Dec 2 2025 Thiruvananthapuram Police have submitted the charge sheet excluding MLA Sachin Dev and MayorAryaRajendranin the case relating to obstructing aKSRTCbus. Only the Mayorsbrother Aravind has.
