My daughter has been using a passage between my property and the neighbors that follows the side of the roadway

There is no sidewalk available but she always walks near the edge of the road as much as possible Feb 6 2021 Can I get charged withtresspassingeven if the property owner doesnt press charges? I was taking pictures and climbed an office rooftop to get a better view

Some people saw me thought I was suicidal and called the cops. The cops gave me a ticket for criminal trespass Aug 8 2012 Criminaltresspassingis a fourth degree misdemeanor punishable by a \$250.00 fine or 30 days in jail

Fleeing and Eluding is actually called Failure to Comply and it could be a first degree misdemeanor or it could go as high as a third degree felony punishable with a five year prison term. There are also various statutory and common law defenses to failure to comply

A person commits the offense of second degree trespass if without authorization he enters or remains on premises of another 1 After he has been notified not to enter or remain there by the owner by a person in charge of the premises by a lawful occupant or by another May 6 2020 You can reporttresspassingto law enforcement send neighbor no trespass warning and or sue civilly for trespass and nuisance

Unfortunately given that neighbor appears mentally unstable none of these is likely to be effective and only involve more contact with this person rather than less Sep 3 2016 In my experience in order to have a notrespassingorder entered by law enforcement the person has to actually be present on your property at the time of the issuance of the warning Jan 29 2014 CriminalTrespassingVSTresspassingI was in a blacked out drunk state and accidentally went into a neighbors house where I passed out on their kitchen floor

The police were called and I was arrested and charged with CriminalTrespassing. I did not knowingly enter their house and I had zero criminal intent in doing so Jul 2 2020 Sorry to hear about your father and what seemed to be a very frustrating situation

If the hospital brought criminal trespass charges against you you should retain counsel to represent you at court and try to get the charges dropped. Also talk to the attorney who drafted the POA to better understand its boundaries and the
