How to use tri in a sentence Oct 1 2025 Each year certain industrial facilities submit Toxics Release Inventory TRI data to EPA. The data are due by July 1 and cover waste management activities that occurred during the previous calendar year. EPA makes these data publicly available

Not all facilities need to report to the TRI Program Nov 18 2025 The Toxics Release Inventory TRI Program tracks the industrial management of toxic chemicals. TRI data are reported annually by industrial and federal facilities that meet reporting requirements Sep 16 2025 Facilities prepare and submit Toxics Release Inventory TRI reporting forms using TRI MEweb
