A unitary business may consist of a single entity or a group of two or more related entities including corporations, tax option corporations, partnerships, limited liability companies, sole proprietorships, estates, and trusts. Tax 2.62 8 b b. Any business conducted directly or indirectly by one corporation is unitary with that portion of a business conducted by another corporation through its director or indirect interest in a pass-through entity if the requirements of s

are otherwise met with respect to the corporation's interests in the Apr 14 2015. For example, Wisconsin states in its regulations that a passive parent holding company that directly or indirectly controls one or more operating company subsidiaries engaged in a unitary business. Therefore, a unitary business may consist of part of a corporation, one corporation, or many corporations.

If the unitary business consists of more than one corporation, the corporations comprising the unitary business shall file a combined return apportioning the business income of the corporations using a single apportionment formula. A Corporation means a subchapter S corporation, any other incorporated entity or any entity defined or treated as a corporation, including but not limited to a limited liability company.

B Person means an individual, a trust, an estate, a qualified employee benefit plan, a limited partnership or a corporation. Feb 21 2024 Partnership income is subject to apportionment as business income of the unitary business when a unitary business relationship exists between the corporation and the partnership. If a unitary business includes income from a pass-through entity, the pass-through entity income to be included in the total income of the combined group shall be the member of the combined group's direct and indirect distributive share of the pass-through entity's unitary business income.
