The laws in each state vary and depending on the severity of the activity the behavior could fall under the legal definitions of abuse and a child could be charged In the United States each state and territory sets the age of consent either by statute or the common law applies and there are several federal statutes related to protecting minors from sexual predators

Depending on the jurisdiction the legal age of consent that is the age at which one can consent to anyone older is between 16 and 18. Many states also include close in age exemptions There are several ways that a person might sexually exploit a child or youth online
