Dec 18 2025 Donna Hughes Brown the Irish woman who has been held in a US immigration detention centre since July is to be released in the coming days following a court hearing on Thursday

Lawyers for the Dec 23 2025 Donna Hughes Brown has reunited with her family after five months in an immigration detention unit in Kentucky Dec 22 2025 Irish citizen Donna Hughes Brown who had been held by immigration authorities in the US for almost five months has said it is fabulous to be free but she is still feeling a bit overwhelmed since Oct 9 2025 Charging documents show that Donna Hughes Brown wrote a bad check worth \$25 about 10 years ago. Hughes Brownsays that she paid the money back and was put on probation

After she returned Sep 10 2025 Donna Hughes Brown 58 was arrested by ICE over a bad check for \$25 she passed a decade ago according to her husband

Born in England the grandmother holds Irish citizenship and first came Donna Hughes Brown 58 who holds a green card was detained by ICE in July after landing in Chicago on a flight from Dublin

She was held in Chicago for five days and then moved to a Dec 14 2025 The case of Donna Hughes Brown the Irish citizen and US green card holder who has been in ICE detention since July is set to be reviewed by the US Secretary of Homeland Security Kristi Noem Aug 28 2025 Donna Hughes Brown a legal permanent resident originally from England was detained by federal authorities at O Hare International Airport in Chicago for five days upon returning to the Sep 11 2025 Donna Hughes Brown a 58 year old green card holder detained July 29 2025 faces deportation over a 2015 \$25 bad check reclassified as a CIMT

Despite restitution and probation completion mandatory detention and expanded enforcement resources have led to fast tracked removal proceedings in Kentucky Sep 10 2025 Donna Hughes Brown who has lived in the United States for decades was detained after returning from Ireland over a decade old \$25 bad check.
